The product manufactured by the company mentioned above is an elastic 1-component sealing compound / adhesive grade which is used for the sealing of plastic components in dishwashers and for the grouting of wall and floor areas in foodstuff processing companies.

Sample sheets were examined by us according to the

Series of standards EN 1186, EN 13130 and CEN/TS 14234 "Materials and Articles in Contact with Foodstuffs – Plastics", current state,

for the migration behaviour.

The analyses performed showed results which ensure that plastic components as well as wall and floor areas manufactured with the sealing compound can meet the requirements of the

Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, Official Journal of the European Union L 338/4 of 13.11.2004, lastly modified by article 5 of the Regulation (EU) 2019/1381 of 20 June 2019, Official Journal of the European Union L 231/1 of 6 September 2019, article 3, 1. (a) and (b),

as well as of the

Lebensmittel-, Bedarfsgegenstände- und Futtermittelgesetzbuches (Lebensmittel- und Futtermittelgesetzbuch - LFGB) in der Fassung der Bekanntmachung vom 15. September 2021 (BGBl. I S. 4253; 2022 I S. 28), zuletzt geändert durch Artikel 11 des Gesetzes vom 6. Mai 2024 (BGBl. 2024 I Nr. 149), §§ 30 und 31,

as far as the influence of the sealing compound and the intended applications are concerned.

as well as of the

Bedarfsgegenständeverordnung in der Fassung der Bekanntmachung vom 23. Dezember 1997 (BGBl. 1998 I S. 5), zuletzt geändert durch Artikel 1 der Verordnung vom 02. Dezember 2021 (BGBl. I S. 5068),

(Consumer Goods Ordinance in the version of the communication of 23 December 1997 (BGBl. 1998 I p. 5), last modification by Article 1 of the Decree of 2 December 2021 (BGBl. I p. 5068)),

are met by the sealing compound for the intended applications.

Thus the sealing compound **Teroson MS 935** according to the sample material submitted may be used safely for the sealing of plastic components in dishwashers as well as for the grouting of wall and floor areas in foodstuff processing companies. However, a direct contact of the sealant with food is not intended for these applications.

This certificate of compliance has a validity of 2 years and consists of 4 pages.
